Recommendation:

THE PINELLAS PLANNING COUNCIL RECOMMENDS THE BOARD OF COUNTY COMMISSIONERS (BOARD), IN ITS CAPACITY AS THE COUNTYWIDE PLANNING AUTHORITY, ADOPT A RESOLUTION ACCEPTING THE AMENDED COUNTYWIDE PLAN MAP AND DIRECT ITS FILING AS ATTACHED.

Summary Explanation/Background:

The Countywide Plan Rules provide for the annual update and filing of the Countywide Plan Map. The Map has been updated to include all the amendments that have been approved by the Countywide Planning Authority (CPA) through the October 6, 2015 meeting.

The following Countywide Plan Map items will be filed with the Clerk of the Board of County Commissioners as the official record copy:

- The 1" = 3000' scale, color Countywide Plan Map;
- The 1" = 3000' scale, color Scenic/Noncommercial Corridor Map.

The PPC, by a vote of 10-0, transmitted this item via Pinellas Planning Council Resolution No. 15-4 with a recommendation for approval of the accompanying CPA Resolution.

I. RECOMMENDATION

Council approve Resolution No. 15-4, recommending acceptance of the updated Countywide Plan Map for filing as the official record copy.

II. BACKGROUND

The Countywide Rules provide for the annual update and filing of the Countywide Plan Map and, in this case, it has been updated to include all the amendments that have been approved through the October 6, 2015 Countywide Planning Authority meeting.

It is recommended the Council approve Resolution No. 15-4, which will transmit the updated map to the Countywide Planning Authority for official acceptance and filing at its December 15, 2015 meeting.

Upon approval of Resolution No. 15-4 and approval by the Countywide Planning Authority on December 15, 2015, the following Countywide Plan Map items will be filed with the Clerk of the Board of County Commissioners as the official record copy:

- a) The 1" = 3000' scale, color Countywide Plan Map;
- b) The 1" = 3000' scale, color Scenic/Noncommercial Corridor Map.

Once this approval process is complete, we will be providing this information via the PPC website at www.pinellasplanningcouncil.org.



WHEREAS, the Countywide Plan was duly adopted by Pinellas County Ordinance No. 15-30 on August 4th, 2015, with an effective date of August 7, 2015; and

WHEREAS, the Countywide Plan Map has been amended by ordinances approved by the Countywide Planning Authority through October 6, 2015, and the Pinellas Planning Council authorized the reprinting of said map consistent with Section 2.2.2 of the Countywide Rules; and
