ADDENDUM NO. 1

Following is additional information, clarifications, questions and responses relative to referenced Request for Proposal (RFP):

QUESTION 1:

- We would like to request the ranking/scoring sheet from the previous Pinellas County LAP proposal.
- . Who are the incumbents, please, and their contact information?

ANSWER 1:

This is a request for new services not previously acquired by the County.

QUESTION 2:

- Are covers and tabs included in the page count?
- Are there any exemptions to the 100 page limit, i.e. Tabs, Letter of Interest, Table of Contents and Appendix 7 Forms?
- Is the Introduction tab (Letter of Interest and Table of Contents) included in the page count?
- Are the forms in Tab 7 excluded from the page count?

ANSWER 2:

Items within the Introduction Tab, Table of Contents, Tab dividers pages and Tab 7 documents are not included in the page limit.

QUESTION 3:

Where should the Vendor References form (Section D) be included?

ANSWER 3:

Tab 5 - item 5

QUESTION 4:

On page 13 and page 21 under Scope of Work – engineering services it list "Hydrogeological" does the hydrogeologic component in the scope mean you're looking for groundwater modeling, or are you looking for a Professional Geologist on the team?

ANSWER 4:

Hydrogeological services include groundwater analysis\modeling as a component of roadway design. Having a professional geologist on the team is not a requirement for this contract.

QUESTION 5:

Is this LAP contract for CEI or miscellaneous design? We are currently on Pinellas County's list of consultants for the 145-0342-CN, Roadways, Drainage, Structural, Civil and Traffic Design Engineering.

Is this contract in addition to that or is it a replacement?

ANSWER 5:

This contract is for design, not CEI, and is in addition to the current continuing contract no. 145-0342-CN. This contract includes requirements for federally funded local agency program design projects.

QUESTION 6:

If we are submitting to be considered for the geotechnical and environmental services, do we have to be FDOT certified?

ANSWER 6:

FDOT certification is not a requirement; however, FDOT Prequalification is a requirement as outlined in the Request for Qualifications, Section B – Special Conditions, sub-paragraph 5.2 Prequalification Requirements.

QUESTION 7:

Do you have a pre-bid sign-in sheet which we may obtain a copy of?

ANSWER 7:

There was no pre-bid meeting for this proposal.

All other specifications, terms and conditions remain the same.
